## 七、業務報告事項 Official Business report matters

- (一)請稅捐稽徵處針對明年重要業務,依據上週討論113年度工作 計畫重點項目,儘速擬定甘特圖,以利掌握工作進度。Taipei City Revenue Service shall draft up Gantt charts as soon as possible based on the key projects of 2024 annual work plan discussed last week to facilitate work progress control.
- (二)請會計室密切注意預算達成率未達80%之府級檢討會議召開時程,並預先調查本局113年度動支第一預備金需求。The Accounting Office should pay close attention to the schedule of Taipei City Government review meetings if the budget attainment rate is below 80%, and in advance investigate the needs of all divisions for the 2024 annual first reserve fund.
- (三) 財產管理系統改版為公產管理科、非公用財產管理科及資訊室之重要業務事項,需與承攬廠商妥善用心溝通,請各主管協助達成於113年度4月開發完成所有程式之目標。 Property management system revamp is a major task of the Public City Property Division, the Non-Public City Property Management Division, and Information Systems Unit. Division supervisors of this plan must collaborate with the outsourced manufacturers continuously, and achieve the goal of completing the development of all programs by April 2024.
- (四)請尚未辦理公職人員財產申報之義務人,注意定期申報之截止時間,以免因逾期申報遭處以罰鍰。To avoid being fined for late submission, public servants who have not yet fulfilled the obligation to declare their properties are reminded to pay attention to the deadline for annual property declarations.
- (五)請各科室參考本市稅捐稽徵處運用 RPA 輔助地方稅人工作業案例,思考有無可應用於市政服務或改善行政作業流程之處。 All divisions should refer to the successful RPA (Robotic Process Automation) use case for the promotion of manual handling operations of local taxes by Taipei City Revenue Service and think about whether there is anything that can be applied to other municipal services or to improve the administrative workflow.
- (六) 2025雙北世界壯年運動會將於2025年5月下旬舉辦,預計召募 1萬4,000名志工,本府分配達6,000個名額,請本局暨所屬二 處動員轄下志工團體,協力召募志工投入,以利運動會順利 舉行。The World Masters Games (WMG) 2025 Taipei & New Taipei City will take place from May 17 to 30, 2025. The organizers will deploy 14,000 volunteers and 6,000 volunteers needed by the Taipei City Government. All divisions should mobilize

their membership to recruit volunteers to participate in this event, so as to facilitate the WMG 2025 goes ahead smoothly.
