Remark: By June 1998, the First Grade Drugs included marijuana and heroine in accordance with the Narcotics Elimination Act, and the Second Grade Drugs included Amphetamine in accordance with the Narcotics and Medicine Control Act.

After July 1998, the Narcotics Hazard Prevention Act was enacted and the drugs were categorized into three grades. The First Grade Drugs are heroin ,morphine, opium, cocaine and other equivalent drugs.The Second Grade Drugs are poppy, coca, marijuana, pethidine, pentazocine, and other equivalent drugs.The Third Grade Drugs are low-dose codeine, FM2 and other equivalent drugs. After January 2005, the Forth Grades Drugs were added into the said Act, including Nimetazepam, ativan, and other equivalent drugs.The nimetazepam has been shifted from the Forth Grade Drug to the Third Grade Drug since September 2006.
